Additionally, the **U.S. dollar has consistently appreciated against the Brazilian real**, making **currency exposure** a strategic alternative for diversification and capital protection.

- Investments may be made through **currency funds, international ETFs, and reserves in strong currencies**, leveraging the historical appreciation of the U.S. dollar against the real.

### **3. Risk Management**

- **No high-risk investments:** The fund will not invest in high-volatility assets, cryptocurrencies, or speculative markets.
- **Diversification:** Spreading investments across multiple asset classes to reduce exposure to individual risks.
- **Continuous Monitoring:** Regular assessment of portfolio performance and risk-adjusted returns.
- **Liquidity Focus:** Maintaining a balance between long-term growth and short-term liquidity needs.

### **4. Reinvestment Strategy**

- **All returns generated by the investment fund will be reinvested initially** to maximize capital growth and token appreciation.
- This **compounding effect** ensures that **\$EMGX token holders benefit from long-term value appreciation**.
